## The pro bono landscape

# What is pro bono?

- *'Pro Bono Publico'*
- It is the provision of free legal services to those who cannot otherwise access justice
- Goal: to further the Rule of Law by promotion of access to justice, without regard to income
- Rationale: professional, moral and ethical responsibility
- Business case

# Pro Bono, Access to Justice and Legal Aid

- Access to justice is '*the ability to obtain a just and timely remedy for violations of rights...*' – United Nations
- Pro bono ≠ legal aid
  - Pro bono **cannot** and **should not** be a substitute for publicly funded legal services

Legal Aid	Pro Bono
Welfare State	Corporate and ethical responsibility
Provided or paid for by the Government	Private lawyers without fee
Means tested and limited to certain types of cases	Support or enhance access to justice for disadvantaged persons or organisations, enhance and/or promote the public interest
Different approaches in common law and civil countries	Well established in common law countries, and a growing movement in civil law countries

# Australian pro bono framework

- National Pro Bono Aspirational Target of 35 hours per year
- Commonwealth 'legal services multi-use list'
- Victorian Government Legal Services Contract Scheme
- National Pro Bono Professional Indemnity Insurance Scheme
- Volunteer Practising Certificates

# Pro bono around the globe

- US
  - Aspirational target of 50 hours per year
  - Some mandatory pro bono hours
- UK
  - Collaborative Pro Bono Plan
  - Aspirational target of 25 hours per year

# Pro bono across the globe

- Continental Europe and Asia
  - Aspirational targets in Vietnam, Indonesia, Philippines
  - RSK: mandatory 30 hours per year
- Middle East and Africa
  - KSA: mandatory 40 hours per year
  - Nigeria: mandatory 20 hours or 3 days per year
  - South Africa: mandatory 24 hours per year

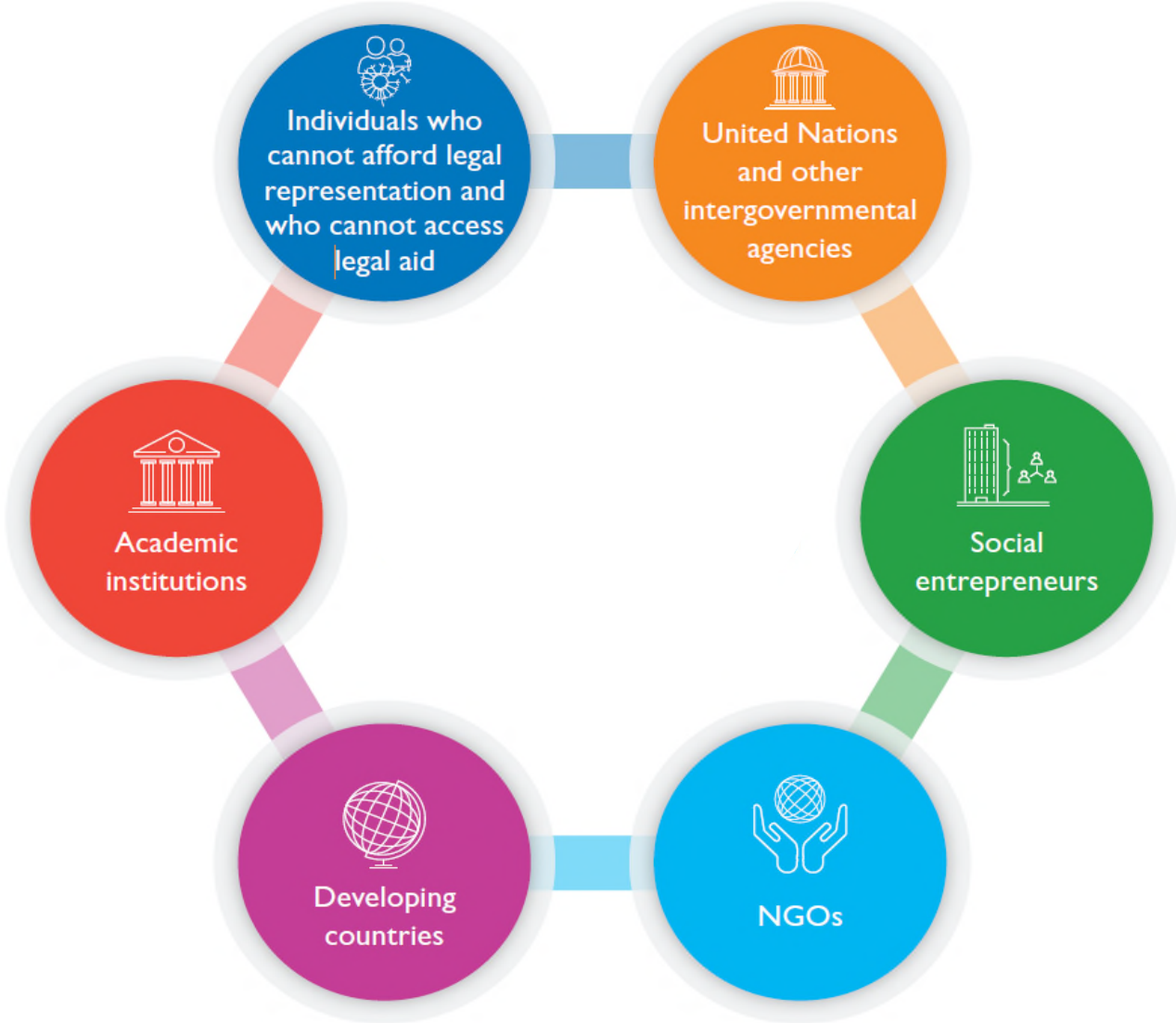
